Cross-border digital policies for Africa: Project Kick-Off

The project *Cross-border Digital Policies for Africa* will complement existing regional mechanisms for stakeholders from the African continent between 2021-2023 to share knowledge, consult each other, interact with stakeholders around the world, and develop a shared understanding of and capacity on cross-border digital policy issues. Through the utilization of regional mechanisms and partnerships, recurring workshops, in-depth data collection, and the development of a first Internet & Jurisdiction in the African Union Regional Status Report, this project will consolidate the timely information needed to enable the necessary capacity building to pursue an inclusive digital transformation based on evidence. It will furthermore ensure meaningful multistakeholder participation and provide the information needed to develop interoperable policy and regulatory frameworks for the digital 21st century, support the evolution of a digital single market, and to contribute to Africa's Agenda 2063 and the UN Roadmap for Digital Cooperation.



Stakeholders currently work in three Programs (Data & Jurisdiction, Content & Jurisdiction, and Domains & Jurisdiction) to jointly develop policy standards and operational solutions to pressing legal challenges at the intersection of the global digital economy, human rights, and security. The organization is also the home of the I&J Retrospect Database tracking global trends and the world's first Internet & Jurisdiction Global Status Report.



BACKGROUND: THE AFRICAN UNION COMMISSION AND INTERNET & JURISDICTION POLICY NETWORK REGIONAL CONFERENCE 2020

On May 27, 2020 the Internet & Jurisdiction Policy Network in partnership with the African Union Commission hosted a Regional Conference for Africa. The virtual event addressed transnational and regional legal challenges in cyberspace, emphasizing the value of multistakeholder cooperation to enable digital transformation.


Key outcomes included:

- Official Africa launch of the world's first Internet & Jurisdiction Global Status Report 2019 that maps key trends and actors of the ecosystem.
- Multistakeholder exchange on internet policy trends that are important for Africa and how they can be addressed by current regional policy dialogues. Issues highlighted by participants included: platform and sharing economy, fake news, impact of the European Union General Data Protection Regulation on data protection and privacy and migration to the cloud amid COVID-19 physical distancing guidelines.
- Dialogue on Internet & Jurisdiction Policy Network Program outcomes including: how public and private decision-makers can determine the geographic scope of content restrictions, why appropriate and proportionate action to address abuse at the DNS level is important for Africa and how to enhance African participation in global discussions on potential regimes for cross-border access to electronic evidence.
- Regional consultation on the future of the UN Digital Cooperation Architecture (Recommendation 5) in the context of the United Nations Secretary General High Level Panel Report on Digital Cooperation and in cooperation with the Government of Germany in its role as UN champion.
- The event gathered regional key stakeholders from governments, Internet companies, technical operators, academia, civil society and international organizations to share perspectives on global trends and discuss the future of the cross-border Internet in an African context in the framework of the Digital Transformation Strategy for Africa, launched by African Heads of State in 2019, as well as the United Nations Sustainable Development Goals (SDGs).

Le projet *Politiques numériques transfrontalières pour l'Afrique* viendra compléter les mécanismes régionaux existants pour les parties prenantes du continent africain entre 2021-2023 pour partager des connaissances, se consulter, interagir avec les acteurs du monde entier et développer une compréhension et une capacité partagées sur les défis politiques transfrontaliers sur Internet. Grâce à l'utilisation de mécanismes et de partenariats régionaux, d'ateliers récurrents, d'une collecte de données approfondies et la rédaction d'un rapport sur le territoire Africain d'Internet & Jurisdiction, ce projet rassemblera les informations chiffrées nécessaires pour permettre le développement des infrastructures nécessaires pour une transformation numérique inclusive. Il garantira en outre une participation multipartite significative et fournira les informations nécessaires pour développer des cadres politiques et réglementaires interopérables pour le 21e siècle numérique, soutenir l'évolution d'un marché unique numérique et contribuer à l'Agenda 2063 de l'Afrique et à la feuille de route des Nations Unies pour la coopération numérique.



L'Internet & Jurisdiction Policy Network est la principale organisation multipartite qui s'attaque aux tensions entre l'Internet et les juridictions nationales. Les parties prenantes travaillent actuellement sur trois programmes (données et juridiction, contenu et juridiction et domaines et juridiction) pour développer conjointement des normes politiques et des solutions opérationnelles aux défis juridiques urgents à l'intersection de l'économie numérique mondiale, des droits de l'homme et de la sécurité. L'organisation abrite également la base de données I&J Retrospect qui suit les tendances mondiales et le premier rapport mondial sur l'état d'Internet et de la juridiction au monde.



CONTEXTE: CONFÉRENCE RÉGIONALE DE LA COMMISSION DE L'UNION AFRICAINE ET DE L'INTERNET & JURISDICTION POLICY NETWORK 2020

Le 27 mai 2020, l'Internet & Jurisdiction Policy Network, en partenariat avec la Commission de l'Union africaine, a organisé une conférence régionale en ligne pour l'Afrique. L'événement a abordé les défis juridiques transnationaux et régionaux dans le cyberspace, soulignant la valeur de la coopération multipartite pour permettre la transformation numérique.

Les principaux résultats comprenaient :

- Lancement officiel du premier rapport Internet & Jurisdiction Global Status Report 2019 qui cartographie les principales tendances et les acteurs de l'écosystème.
- Échange multipartite sur les tendances politiques de l'Internet qui sont importantes pour l'Afrique et comment elles peuvent être abordées par les dialogues politiques régionaux actuels. Les problèmes soulignés par les participants comprenaient : l'économie des plateformes et du partage, les informations erronées, l'impact du règlement de l' European Union General Data Protection Regulation sur la protection des données et la migration vers le cloud dans le cadre des directives de distanciation physique COVID-19.
- Dialogue sur les résultats du programme Internet & Jurisdiction Policy Network, y compris : comment les décideurs publics et privés peuvent déterminer la portée géographique des restrictions de contenu, pourquoi une action appropriée et proportionnée pour lutter contre les abus au niveau du DNS est importante pour l'Afrique et comment améliorer la participation africaine aux discussions mondiales sur les potentiels règles internationales d'accès aux preuves électroniques.
- Consultation régionale sur l'avenir de l'UN Digital Coopération Architecture (Recommandation 5) dans le contexte du United Nations Secretary General High Level Panel Report on Digital Cooperation et en coopération avec le gouvernement allemand dans son rôle de leader des Nations Unies
